A PARCEL OF LAND LYING IN SECTION 10, TOWNSHIP 29 SOUTH, RANGE 24 EAST, POLK COUNTY, FLORIDA; BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING FROM THE SOUTHWEST CORNER OF THE SOUTHWEST 1/4 OF THE SOUTHEAST 1/4 OF SAID SECTION 10; THENCE NORTH 89°40'13" EAST, 19.56 FEET; THENCE NORTH 00°19'47" WEST, 40.00 FEET TO THE POINT OF BEGINNING SAID POINT ALSO BEING AT THE INTERSECTION OF THE NORTH RIGHT-OF-WAY LINE OF CLUB HOUSE ROAD AND THE EASTERLY MAINTAINED RIGHT-OF-WAY LINE OF BANANA LAKE ROAD AS RECORDED IN MAP BOOK 15, PAGES 55 THROUGH 63 IN THE THE PUBLIC RECORDS OF POLK COUNTY, FLORIDA; THENCE NORTH ALONG SAID EASTERLY MAINTAINED RIGHT-OF-WAY LINE THE FOLLOWING FOUR (4) COURSES; (1) NORTH 23°09'52" WEST, 11.95 FEET; (2) NORTH 02°48'15" WEST, 96.35 FEET; (3) NORTH 00°15' 04" EAST, 270.11 FEET; (4) NORTH 89°29'33" EAST, 4.46 FEET TO THE SOUTHWEST CORNER OF TRACT "B", CLUBHOUSE HERITAGE AS RECORDED IN PLAT BOOK 117, PAGE 10 OF THE PUBLIC RECORDS OF POLK COUNTY, FLORIDA; THENCE CONTINUE NORTH 89°29'33" EAST, ALONG THE SOUTH BOUNDARY OF SAID TRACT "B", 20.69 FEET; THENCE SOUTH 00°32'36" EAST, 377.45 FEET TO A POINT ON SAID NORTH RIGHT-OF-WAY LINE OF CLUB HOUSE ROAD; THENCE SOUTH 89°40'13" WEST ALONG SAID NORTH RIGHT-OF-WAY LINE, 20.50 FEET TO THE POINT OF BEGINNING. 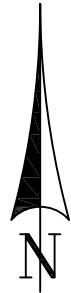

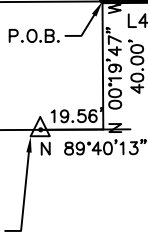
EXISTING NORTH R/W LINE
